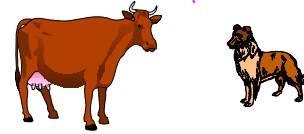

## TRADE SPACE INFORMATION

**Special Note: Commemorative 100 years sash will be awarded to BEST TRADE SITE DISPLAY**

1. **FEES:** Your site fee includes 2 personal passes.
2. **HOURS OF OPERATION:** We ask again for your co-operation in staffing your display from 9am through to 5pm each day to ensure value for patrons and maximising promotion for your own business. This year we will not tolerate any exhibit taking down their display prior to 5pm unless it is discussed either with the Trade Steward or with the President.
3. **SECURITY:** We are engaging the services of a security firm for four nights – Wednesday to Saturday inclusive. The Showgrounds will be open on Sunday morning. Even though we do have a Security service, may I suggest that some exhibitors may like to take extra precautions by packing away little items that may be valuable.
4. **CONDITIONS OF PARTICIPATION:** Please refer to *General information - Notice to Ground Users*, at bottom of Trade Site form which sets out certain conditions which apply for the period 11<sup>th</sup> to 12<sup>th</sup> September 2009 inclusive. **We ask that you especially refer to Conditions 4 & 6 at the latest all Trade must be cleared by Sunday 13<sup>th</sup> September 2009.**
5. **PRODUCT/SERVICE/FOOD:** We note that over the years, some exhibitors change their range of products/services, etc. In our efforts to maintain a high standard and well-balanced range of exhibits and outlets, it would be appreciated if you would provide a brief update/outline of details of your product/service/food line, etc. Therefore, please ensure that Section 2 of the Expression of Interest Form is completed for our records.
6. **PUBLIC LIABILITY INSURANCE:** In line with prudent business practice, we are aware of the need for you to hold Public Liability Insurance Cover. Please provide a copy or certificate of currency.
7. **CONFIRMATION OF SITE:** We again have the *healthy* problem of demand for sites far exceeding our capacity to supply. As a consequence, you will appreciate our need for prompt confirmation of your site with payment and return of Expression of Interest Form as soon as possible please. All applications close 4<sup>th</sup> September 2009
8. **SITE ALLOCATION:** Please make yourself none at the Office onsite on Thursday before you set up. The site referred to in the Trade Site Form is the same as last year, or the next most comparable site to it. It is at the Show Society's discretion to move any trade exhibitors to a site deemed more appropriate. Should you wish to discuss any aspect of your presence at the Show, please contact us immediately.
9. **EFTPOS:** Facilities will again be available from a terminal at the Cashiers window in the Secretary's Office. This has proved to be a very valuable service to spectators and all Show personnel.
10. **ADVERTISING & SPONSORSHIP OFFER:** We have available advertising for the 2009 Noosa Country Show. We will be printing our own feature to be distributed the week prior to the Show and advertising is available for all site-holders in this publication for a fee. 11. **SHOW ENTERTAINMENT:** The Show Society is planning to continue with the policy of providing a wide range of quality great entertainment for the full two days and nights of the Show culminating with a Rodeo. Friday night will be a spectacular Fireworks display. This is only a fraction of the entertainment that we have planned for the 100<sup>th</sup> Noosa Country Show in 2009.
12. **UPSTAIRS, MAIN PAVILION:** The Upstairs Main Pavilion is accessible by either stairs at the front or by ramp at the rear of the building. Again we will be showcasing the work of many of the community who endlessly surprise us with their exceptional talents whether it be cooking, handcraft, photography, and even our children with Junior Art.
13. **SHOW PROMOTION:** The Society will again promote the Show in all forms of media throughout the Sunshine Coast and surrounds (i.e. through our major sponsors, Cooroy Rag, Noosa News, Noosa Journal, Noosa Community Radio, Zinc FM/Hot FM, Noosa Classic Hits & 4GY, Coast FM, Local Channel Seven, and copies of the *Show Programme* will be available the week prior to the Noosa Country Show). This will have the full Show Programme for two days.

If you are a **new Exhibitor**, please do not hesitate to make an appointment to come into the Showgrounds so you can actually see the grounds and possible sites available.

Once again I must stress that trade site areas are taken up very quickly once this Form is received by the Exhibitors. So please get your intentions known to us as soon as possible.
