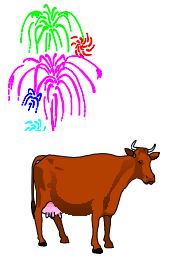

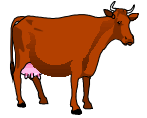

TRADE SPACE INFORMATION- DO NOT RETURN THIS PAGE

- FEES:** This year we have reduced site fees; but you will have to buy entry passes (at a reduced rate) separately (see form).
- HOURS OF OPERATION:** We ask again for your co-operation in staffing your display from 9am through to 5pm each day to ensure value for patrons and maximising promotion for your own business. We will not tolerate any exhibit taking down their display prior to 5pm unless it is discussed either with the Trade Site Steward or with the President.
- SECURITY:** We are engaging the services of a security firm for four nights – Wednesday to Saturday inclusive. The Showgrounds will be open on Sunday morning. Even though we do have a Security service, may I suggest that some exhibitors may like to take extra precautions by packing away little items that may be valuable.
- CONDITIONS OF PARTICIPATION:** Please refer to *General information - Notice to Ground Users*, at the bottom of the Trade Site form which sets out certain conditions which apply for the period 9th to 10th September 2011 inclusive. **We ask that you especially refer to Conditions 4 & 6: “at the latest, all Trade sites must be cleared by Sunday 11th September 2011.”**
- PRODUCT/SERVICE/FOOD:** We note that over the years, some exhibitors change their range of products/services, etc. In our efforts to maintain a high standard and well-balanced range of exhibits and outlets, it would be appreciated if you would provide a brief update/outline of details of your product/service/food line, etc. Therefore, please ensure that the product description of the Trade Site Application Form is completed for our records.
- CONFIRMATION OF SITE:** We again have the *healthy* problem of demand for sites far exceeding our capacity to supply. As a consequence, you will appreciate our need for prompt confirmation of your site. Please return your Trade Site Application with payment and insurance details as soon as possible. All applications close 29th August 2011.
- SITE ALLOCATION:** Please make yourself known at the Office on site on Thursday before you set up. The sites referred to in the Trade Site Application are the same as last year, or the next most comparable site to it. It is at the Show Society’s discretion to move any trade exhibitors to a site deemed more appropriate. Should you wish to discuss any aspect of your presence at the Show, please contact us immediately.
- EFTPOS:** Facilities will again be available from a terminal at the Cashier’s window in the Secretary’s Office. This has proved to be a very valuable service to spectators and all Show personnel.
- ADVERTISING & SPONSORSHIP OFFER:** We have available advertising and sponsorship for the 2011 Noosa Country Show in our schedule that is distributed before the Show. If you are interested in advertising in this Schedule, please call the office on 07 5485 2331 (please leave message for a return call if no answer) or email secretary@noosashowsociety.org.au Arrangements must be made before **end of April 2011** to ensure you are included in the schedule.
- SHOW ENTERTAINMENT:** The Show Society is planning to continue with the policy of providing a wide range of quality great entertainment for the full two days and nights of the Show culminating with a Rodeo. Friday night will be a spectacular Fireworks display. This is only a fraction of the entertainment that we have planned for the 102nd Noosa Country Show in 2011.
- UPSTAIRS, MAIN PAVILION:** The Upstairs Main Pavilion is accessible by either stairs at the front or by ramp at the rear of the building. Again we will be showcasing the work of many of the community who endlessly surprise us with their exceptional talents whether it be cooking, handcraft, photography, and even our children with Junior Art.
- SHOW PROMOTION:** The Society will again promote the Show in all forms of media throughout the Sunshine Coast and surrounds (i.e. through our major sponsors, Cooroy Rag, Noosa News, Noosa Journal, Noosa Community Radio, Zinc FM/Hot FM, Noosa Classic Hits & 4GY, Coast FM, Local Channel Seven, and copies of the Show Schedule will be available some weeks prior to the Noosa Country Show). This will have the full Show Programme for two days.

If you are a **new Exhibitor**, please do not hesitate to make an appointment to come into the Showgrounds so you can actually see the grounds and possible sites available.

Once again I must stress that trade site areas are taken up very quickly once this Form is received by the Vendors. So please get your intentions known to us as soon as possible.

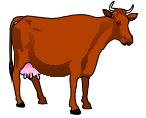

- All trade exhibitors are required to remain on show until Saturday, **5pm**.
- Set up time – Thursday prior to show from 10am. (earlier by negotiation)
- All applications close 29th August prior to show. All monies must accompany application. **No** refunds will be made after this date.
- All sites will be allocated by Site Manager/Assistant.
- Bond to be paid with application. Bond will be returned on Saturday show day after **5pm** if site left clean and tidy, collect at Office
- Passes will be posted with a tax receipt.
- The above person nominated as contact name must be the person that is working the trade site.
- 15amp 30 metres electric extension leads may be hired for \$5.50 (A \$40 bond is charged at time of collection and the balance will be refunded when the lead is returned in good order)

This release continues forever and binds all of my heirs, successors, executors, personal representatives and assigns.

I acknowledge that it is a condition of exhibiting in the Show that the Society and any person or body directly or indirectly associated with the Show are absolved from all liability arising for injury or damage to myself or my property howsoever caused arising out of my exhibiting in the Show.

I acknowledge that the Society relies on the information provided by me and state that all such information is accurate and complete.

I acknowledge that I must produce evidence to the Society that I have a current policy of public liability insurance.

I acknowledge that I will ensure that my site is safe and without risks to health as far as practicable; and in particular, that all Workplace Health and Safety Regulations will be adhered to. This includes but is not limited to the following.

1. All electrical equipment will be tested and tagged in accordance with Australian standards.
2. Extension leads will be tagged with the owners name.
3. Extension leads must not constitute a hazard in the manner in which they are used.
4. Extension leads must be continuous from power box to appliance (no joined leads)
