## STALLHOLDER TERMS & CONDITIONS - 2022

### **COVID -19 Requirements – Subject to change – Covid guidelines will be enforce at the time of the show.**

Stallholders must satisfy all COVID-19 requirements both on Bump In/Out and at the Show over the two days.

Stallholders must have their own COVID safe plan in place for their stall and provide a copy to the Society prior to the show. COVID safe plans must follow the key COVID safe principles relating to COVID screening, physical distancing, sanitising, signage, entry/exit points, foot markers etc.

#### **Stallholders must also:**

- Ensure that their stall is set up in a manner preventing and or managing pedestrian queuing or pinch point gathering of people.
- Provide their own sanitiser and signage and other consumable items relating to their COVID safe plan.
- Promote contactless payment methods.
- Not offer self-service to food or beverages.
- Operate their stall in a COVID safe manner.

#### **Application**

Complete application, waiver forms and return to Administration with COVID-19 Safe Plan and Certificate of Insurance.

#### **Approval**

Stallholders checked against the banned stallholders list as issued by the Queensland chamber of Agricultural Societies Inc. Stallholders with outstanding monies not approved. A limited number of operators offering the same goods/services approved. The Society committee conducts the approval process.

#### **Stalls**

All stallholders must ensure that stalls are of show standard with suitable stands and backing. Stallholders shall not assign or sublet any part of allocated space without the consent of the Noosa Show Society committee. The site allocated MUST not be changed to another site without the approval of the Noosa Show Society committee.

The Society reserves the right in unforeseen circumstances to change the allocated site to another site deemed more suitable.

#### **Banned Items**

Stallholders should take care in selecting suitable lines of products to display or sell. A committee member of the Society may enter your area assigned and remove any article, sign, picture or printed matter, as per the Federal Council of Agricultural Society's list of "Banned Items".

#### **Bump In**

"Bump In" is available Thursday 8<sup>th</sup> from 9am to 4.00 and from 7am Friday 9<sup>th</sup>.

Stallholder vehicles MUST park outside the Showgrounds once set up is complete.

#### **Stall Trading Hours**

Stallholders must have their stalls set up and ready for operation by 8am Friday 9<sup>th</sup> and Saturday 10<sup>th</sup> September 2022.

All stallholders must trade from 9am until 5.00pm each day to ensure value for patrons and maximising promotion for your own business. We will not tolerate any exhibit taking down their display prior to 5pm unless discussed with a member of the Noosa Show Society. The Society welcomes night-time trading. All stallholders should clear their sites by Sunday.

#### **Security**

Security will be provided on site for three nights – Thursday to Saturday inclusive, however, exhibitors should take extra precautions by packing away little valuable items.

#### **Insurance**

Stallholders must hold relevant insurance cover. The Noosa A.H & I Society Inc not held responsible for any loss of goods or damage. Stallholders must supply with application a copy of public liability certificate of currency.

#### **Plastic – Single Use Items Ban – 1 September 2021**

- Single use plastic bags. (banned 2018)
- Straws: regular straws, flexible straws, straws with a scoop, cocktail straws and bubble tea straws.
- Cutlery: knives, forks, spoons, teaspoons, sample tasting spoons, soupspoons, chopsticks, splayds and sporks.
- Stirrers; hot or cold drink stirrers, swizzle sticks and hot or cold food stirrers.
- Expanded polystyrene takeaway food containers and cups, for example 'clamshell' style containers.

While single-use plastic straws and cutlery are banned, they can continue to be attached to shelf-ready, pre-packed products. Examples include a juice box with an attached single-use plastic straw or yoghurt with an attached single-use plastic spoon.

#### **Food Business License**

Mobile Food Licenses issued by any Qld council can operate lawfully at the Noosa Country Show. Temporary food stalls must apply to Noosa Council (07 5329 6500) prior to the show date.



## STALLHOLDER WAIVER - 2022

### Waiver, Release and Acknowledgement Form

In this Waiver, Release and Acknowledgement Form “the Society” means and includes all affiliated entities; servants or agents of the Society, employees of the Noosa A.H. & I Society Inc, and members of the Society and volunteers of the Society.

#### **By Exhibiting in the Show:**

I acknowledge that it is a condition of exhibiting in the Show that I do so at my own risk. I accept all risks and release the Society from all claims, demands and proceedings arising out of or connected with my exhibiting in the Show. I indemnify the Society together with any other organisation or person involved in the conduct of the Show against all liability for any injury, loss or damage arising out of or connected with my exhibiting in the Show. This release continues forever and binds all of my heirs, successors, executors, personal representatives and assigns.

I acknowledge that it is a condition of exhibiting in the Show that the Society and any person or body directly or indirectly associated with the Show absolved from all liability arising for injury or damage to myself or my property howsoever caused arising out of my exhibiting in the Show.

I acknowledge that the Society relies on the information provided by myself is accurate and complete.

I acknowledge that I must produce evidence to the Society that I have a current policy of **Public Liability Insurance**.

I acknowledge that I **MUST** provide a copy of the business **COVID Safe Plan** for my stall and **MUST** ensure that the stall meets the Key Principles of COVID safe requirements at all times.

I acknowledge that I will ensure that my site is safe and without risks to health as far as practicable; and in particular, that all Workplace Health and Safety Regulations will be adhered to. This includes but is not limited to the following.

- All electrical equipment will be tested and tagged in accordance with Australian standards.
- Extension leads tagged with the owner’s name.
- Extension leads must not constitute a hazard in the manner in which they are used.
- Extension leads must be continuous from power box to site (no joined extension leads)

I acknowledge that failure to comply with any of the above may lead to eviction from the Showground.

*I acknowledge that I have read this form or been explained to me. I fully understand its terms and that I have given up substantial rights by signing it. I have signed the document freely and voluntarily without any inducement made to me and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.*
