Present online entry receipt with all exhibit deliveries and collections.

No entries taken after this date.

Competitors Pass - online entrants - purchase at time of class nomination and present confirmation email at the gate.

1. **Artwork Delivery:** Squash Courts Pomona Showground from 9am to 7pm Wednesday 7 September 2022.
2. **Artwork Collection:** Squash Courts Pomona Showground from 10am to 12pm Sunday 11 September 2022.
3. Only one (1) entry per category.
4. Artwork delivery must accompany online entry receipt.
5. No artwork released without presentation of receipt.
6. The Steward reserves the right to declare a non-competition in any class if there is insufficient entries.
7. All entries must be the original work of the exhibitor.
8. Due to the availability of space, selection for hanging Artwork will be at the Judges discretion.
9. All entries are subject to General Show Rules.
10. All works must be suitable for general viewing.
11. The Stewards decision is final.
12. Works awarded a prize previously; will not be eligible for entry in any category.
13. The Society accepts no responsibility for loss or damage. Recommended artists insure their work.
14. The officials of the Noosa Country Show will exercise all reasonable care with exhibits
15. Artwork for sale; Artists must nominate the sale price and agree to 25% commission to the Society if sold. Buyer will pay for the full sale price to the Society. The Society will then pay the Artist the sale price less the 25% commission as agreed.
16. The Noosa A.H & I Society Inc reserves the right to reproduce any pictures of work in the Press, TV or on Social Media.
17. Exhibitor's submission of entry implies acceptance of all conditions listed and the General Show Rules.
18. Ribbons, certificates and prize money issued by Steward at time of artwork collection.

EXHIBITION REQUIRMENTS

- Works must be ready to hang with cord on "D" hooks and must not exceed 1.2m width or height.
- Title, Medium, Name, Address and Phone Number of Artist MUST be clearly printed on the back of each work.
